



E. Garciadelarosa



District 2 Arrests

Devonte Robinson



Inv. M. Morrow solved a burglary of a home under construction in the northern part of District 2 within 24 hours of the event due to the victim providing serial numbers on items stolen. A check of records provided by local pawn shops revealed Devonte Robinson had pawned some of the stolen items.

Arrested: Devonte Levon Robinson age 22, of Pike Road Charges: Receiving Stolen Property second degree.

Video provided by the victim along with other evidence collected by Investigators at the scene of burglaries of storage facilities at a District 2 Mini Warehouse business led to clearing the cases by arrest. Deputies working with other Montgomery area law enforcement agencies were able to identify the suspects seen in the video as they committed the burglary and theft. The below have been arrested and charged in the case.





District 3 Arrest

Shane Callis



In March Investigator M. Morrow investigated a reported burglary and theft at a business in District 3. Video surveillance from the business recorded at the time of the burglary provided a description of a suspect.

In April Morrow investigated the burglary of two storage sheds at a District 1 business. A witness working at another business nearby provided information to Morrow which led to clearing the District 1 burglary by the arrest of Shane Callis. Morrow recognized Callis as the perpetrator in the District 3 video and charged him in that burglary also.

Arrested: Gary Shane Callis age 36, of Wetumpka.

Charges: Burglary III (3 cts.), Theft I (2 cts.), B&E Vehicle, Parole Violation.

Jeffrey Ellisor



A District 3 resident whose home was burglarized was told by a neighbor that she saw a suspect who lived in the same community carrying items away from the residence. Investigator K. Sage interviewed the witness and then developed sufficient probable cause to arrest Jeffrey Lane Ellisor in the case.

Arrested: Jeffrey Lane Ellisor age 44 of Montgomery.

Charges: Burglary III, Theft IV, Criminal Mischief I, Probation Revocation.





Map showing 2019 Residential Burglaries in southern District 4





The Montgomery County Sheriff's Office is now accepting applications for our *Citizens Academy*. The Citizens Academy was established in 1997 to educate the citizens of Montgomery County on how the Sheriff's Office operates and to promote public safety among our community members. Montgomery County Sheriff's Office TO INCREASE ACCESS TO SAFE MEDICATION DISPOSAL WITH DRUG COLLECTION UNIT DONATED BY CVS HEALTH

Joint effort by CVS Health and Partnership for Drug-Free Kids aims to combat drug abuse, encourage safe drug disposal in local communities

On Friday, March 17, 2017, the Montgomery County Sheriff's Office unveiled their new drug collection unit they received as part of CVS Health's Medication Disposal for Safer Communities Grant Program. The new unit will be located at Administrative Office of the Sheriff, at 100 South Lawrence (2nd floor lobby) and will provide residents with a safe and environmentally responsible way to dispose of unwanted, unused or expired medication, including controlled substances.

"CVS Health is dedicated to helping the communities we serve address and prevent prescription drug abuse," said Tom Davis, R.Ph. Vice President of Pharmacy Professional Services at CVS Health. "Reducing the amount of unused and unwanted medication in the home is critical to preventing prescription drug abuse. We are proud to work with the Partnership for Drug-Free Kids and local leaders to increase convenient access to safe medication disposal."

The new drug disposal unit will help to reduce the amount of unneeded medicine in residents' homes and decrease the potential for prescription drug abuse, which has soared in recent years, especially among teenagers. More than 70 percent of teenagers say it is easy to get prescription drugs from their parents' medicine cabinets, according to a Partnership for Drug-Free Kids study. Proper drug disposal also helps to prevent the contamination of local landfills and water supplies from unused medication.

Over the last few years, the Montgomery County Sheriff's Office has participated with the Drug Enforcement Agency (DEA) and their Drug Take Program. We have collected hundreds of pounds of unused or expired medication. "Sheriff Derrick Cunningham and the staff of the Montgomery County Sheriff's Office are proud to partner with CVS and would like to thank them for providing this grant opportunity. This Drug Collection Unit will help us offer the citizens of Montgomery a safe, convenient, and responsible means of disposing of prescription drugs, while also educating them about the potential for abuse and misuse of medication". The Medication Disposal for Safer Communities program has donated more than 600 drug collection units to law enforcement agencies across the country, which have collected more than 47 metric tons or 100,000 pounds, of unwanted medication. CVS Health also assists law enforcement by supporting local drug take back events and promoting local drug disposal collection sites.

MCSO Firearms Familiarization Course



We have already begun our firearms course to "familiarize" Montgomery County citizens about the laws and proper use of a firearm. We know that learning how to protect yourself is very important in today's world. Our course is held one Saturday a month. The next class has been scheduled for the following date:

The class is held at our Sheriff D. T. Marshall Firearms Training Center located at 6900 Janet

Warner Road and is **FREE** to Montgomery County citizens! The morning session is classroom instruction on firearm safety and firearm laws. The afternoon session allows citizens to practice shooting on our Firing Range for the remainder of the class (if you would like). All classes are under the instruction of the Montgomery County Sheriff's Office Range Master.

Sheriff's Office APP

The Montgomery County Sheriff's Office has a new phone app called "Montgomery County AL Sheriff" that can be accessed through your phone's app store. Once you have added this app to your phone, you can easily set your phone up to receive important push notifications. Push notifications are quick, important messages that can notify you of road closure(s), blocked road(s), anything pertinent to your travel, escapee, etc. While our app can help you with many things

including checking to see if someone is in the county jail, it is most helpful to receive push notifications. After you have downloaded the app, go through the follow steps to make sure your phone is set up to receive the push notifications:



- Go to your phone's setting icon
- Scroll down and click "Applications"
- Scroll down to "MCSO" or "Montgomery County Sheriff"

OR



- Click "Application Manager", if it doesn't take you directly to the location
- Click "Notifications"
- Turn 'on' "Allow Notifications" and "Previews in pop-ups"

You should be all set to receive the Montgomery County Sheriff's Office push notifications!
